AN ACT

1 Amending Title 34 (Game) of the Pennsylvania Consolidated  
2 Statutes, in hunting and furtaking licenses, further  
3 providing for resident license and fee exemptions and for  
4 license costs and fees.

5 The General Assembly of the Commonwealth of Pennsylvania  
6 hereby enacts as follows:

7 Section 1. Sections 2706(b)(1) and 2709(a)(4), (5), (6),  
8 (7), (20), (21) and (22) of Title 34 of the Pennsylvania  
9 Consolidated Statutes are amended to read:

10 § 2706. Resident license and fee exemptions.

12 (b) Disabled veterans.--

13 (1) Any resident disabled veteran who has a disability  
14 incurred in any war or armed conflict which consists of the  
15 loss of one or more limbs, or the loss of the use of one or  
16 more limbs, or who is 100% disabled as certified by the  
17 United States Department of Veterans Affairs, and who meets  
18 all other qualifications of this title and is otherwise

1 mentally and physically fit, shall [be issued a free regular  
2 hunting or furtaking license], upon application to the  
3 commission or a county treasurer[.], be issued any of the  
4 following licenses without cost:

- 5 (i) Regular hunting.
- 6 (ii) Regular furtaking.
- 7 (iii) Antlerless deer.
- 8 (iv) Bear.
- 9 (v) Archery.
- 10 (vi) Muzzleloader.
- 11 (vii) Migratory game bird.
- 12 (viii) Elk.
- 13 (ix) Special wild turkey.

15 § 2709. License costs and fees.

16 (a) License costs.--Any person who qualifies under the  
17 provisions of this chapter shall be issued the applicable  
18 license upon payment of the following costs and the issuing  
19 agent's fee:

21 (4) Bear hunting:

- 22 (i) Resident - \$15.
- 23 (ii) Nonresident - \$35.
- 24 (iii) Resident disabled veteran - no cost.

25 (5) Antlerless deer:

- 26 (i) Resident, including resident military[, resident  
27 disabled veteran] and landowner - \$5.
- 28 (ii) Nonresident - \$25.
- 29 (iii) Resident disabled veteran - no cost.

30 (6) Archery deer:

- 1 (i) Resident - \$15.
- 2 (ii) Nonresident - \$25.
- 3 (iii) Resident disabled veteran - no cost.

4 (7) Muzzleloader deer:

- 5 (i) Resident - \$10.
- 6 (ii) Nonresident - \$20.
- 7 (iii) Resident disabled veteran - no cost.

9 (20) Migratory game bird hunting license:

- 10 (i) Resident - \$2.
- 11 (ii) Nonresident - \$5.
- 12 (iii) Resident disabled veteran - no cost.

13 (21) Elk hunting license:

- 14 (i) Resident - \$25.
- 15 (ii) Nonresident - \$250.
- 16 (iii) Resident disabled veteran - no cost.

17 (22) Special wild turkey license:

- 18 (i) Resident - \$20.
- 19 (ii) Nonresident - \$40.
- 20 (iii) Resident disabled veteran - no cost.
